3. GOVERNANCE

The following items were discussed during governance:

INTERAGENCY AGREEMENT BY AND BETWEEN THE CITY OF JACKSONVILLE AND DCSB OF GENERAL COUNSEL:

Michael Fackler, Office of General Counsel joined in the discussion on the following:

- A flat rate fee to replace the current time-based fee. This fee would be the cost of hiring three (3) attorneys, a staff person any additional costs such as time representation for items such as the Carter G. Woodson demolition, and the costs of programs needed for them to perform their jobs. Currently, there are 4 applicants, only 2 with experience. He would like to have someone certified in education and would like to move forward with checking references for the current applicants.
- A request was made to rehire Ray Poole on an interim basis to cover the Board Meetings as he is board certified in education law. His rate of pay and available hours were explained. It was requested to wait until Chairman Joyce returns to move forward with this decision for a permanent attorney and to use Mr. Poole in the interim.
